CACFP UPDATES

New Meal Pattern Updates:

- To assist with implementing the new CACFP meal patterns (which go in to effect October 1, 2017), the DPI will be rolling out a series of handouts that feature a select component of the new meal pattern. Each handout will review the current and new requirements of the meal patterns. The goal of this roll out is for provider to build on what they can do now and implement the changes slowly for a successful transition.

- What’s one of the biggest changes coming to the milk requirement that you can implement now? Flavored milk will no longer be creditable when served to 1 to 5 year olds.
