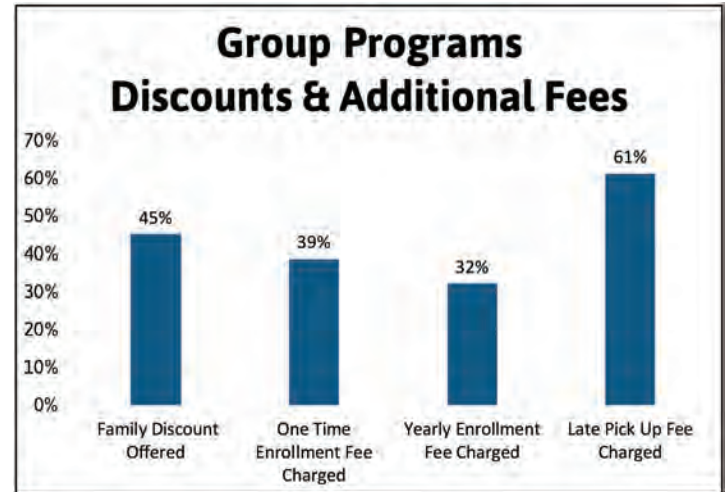

- Late pick up fees vary from \$1/minute up to \$25 for every 30 minutes. The majority of programs charged \$1/minute.
