## **\$15,000** Bi-annual expense to sponsor a **Play & Learn** location

**Play & Learn** sessions provide parents and caregivers a **free** opportunity to bring their children (ages 3+) to a space where they can **meet with other caregivers** as our specialists model appropriate engagement, **encourage positive interactions**, and share resources to **help with challenging behaviors**.



## **\$10,000** Annual cost of a rural **Resource on the Road** route

Our **Resources on the Road** initiative brings early childhood resources to child care providers and families in rural Wisconsin communities. This provides **equitable access to high quality resources** such as children's books, activity backpacks, and themed toy kits.



## **\$5,000** Funds needed to hold a **Parent Café** series

During **Parent Café** sessions, **parents and caregivers** can share concerns related to raising their children. These allow an **opportunity for socialization** with others going through similar situations and are structured to provide a **positive influence and support** in their lives. Each Parent Café session includes a full family style meal and child care for all participants.



## **\$2,500** Cost to train a **WI Pyramid Model** cohort

The **Pyramid Model** is a tool used by **early childhood teachers** that **promotes healthy social and emotional development** and prevents challenging behaviors by supporting positive relationships, creating engaging environments, and **providing concrete teaching strategies**.
