TIERING / INCOME RENEWALS

The Keep Kids Fed Act (KKFA) that allowed temporary additional reimbursement for CACFP ends June 30, 2023. This includes the additional 10 cents for all CACFP meals/ supplements and for Tier 1 rates for all family day care homes in CACFP. THIS MEANS THAT USDA TIERING REQUIREMENTS **WILL RESUME JULY 1, 2023.**

Income renewal information will be sent the week of July 3rd to all providers who have qualified in the past for Tier 1 rates based on income as well as providers who qualify by school/census and claim their own children. If you receive income renewal information from us either by mail or email, please complete the form(s) and send in with any required documentation no later than July 21, 2023.

It is extremely important you submit all paperwork on time in order to allow time for it to be processed and approved by July 31st to qualify for Tier 1 rates for your July 2023 claim.

You will only automatically receive income renewal information if you were at Tier 1 based on income prior to the nationwide tiering waiver.

Please let us know if your income and/or household size has changed and you would like to apply for Tier 1 reimbursement - we will be more than happy to send you the proper forms. ANNUAL RECORD KEEPING ASSIGNMENT

A reminder that it is a requirement from DPI and USDA to complete this training in order to continue participating in the Food Program. Although you technically have until September to complete the training to meet the requirement, we highly encourage you to complete it as soon as possible as this will give your Nutrition Specialist time to review any of the questions with you at home reviews.
